**CIRCULAR**

**Course Registration- July-Nov 2025**

**I. Schedule for Semester Course Registration:**

- ❖ The course registration portal for the July–November 2025 semester is open from 18.07.2025. All students are required to complete their semester course registration well in advance within the stipulated period.
- ❖ The registration portal will be closed for all students after 29.07.2025, as classes are scheduled to commence from 30.07.2025.
- ❖ There will be a provision to ADD/DROP of Elective courses during 06.08.2025-08.08.2025, and no requests will be accepted after 08.08.2025.

**Instructions to the students:**

- ❖ Students are advised to create APAAR Id (AUTOMATED PERMANENT ACADEMIC ACCOUNT REGISTRY) on the Digilocker portal (<https://www.digilocker.gov.in/>) prior to semester course registration.
- ❖ Students are required to generate the anti-ragging affidavit at [http://www.antiragging.in/affidavit\\_university\\_form.php](http://www.antiragging.in/affidavit_university_form.php). The affidavit will be mandatory for submission at the time of enrollment.
- ❖ Students who have remitted the fees and completed the semester course registration will ONLY be allotted Hostel Rooms and they will be permitted to complete enrollment and attend the classes from 30.07.2025
- ❖ Students with less than 6.0 CGPA are required to meet FA and HoD along with their parents in between 28.07.2025 & 29.07.2025 (you are advised to fix an appointment through email prior to the meeting) and should submit form C10 at Academic office failing which you will not be permitted to complete the semester course registration.
- ❖ It is mandatory to register for all the core courses.
- ❖ Those who register for elective courses (In-house & NPTEL) shall ensure in consultation with FA/HoD that there is no more than 20% overlap with already credited core & elective courses.
- ❖ Go through the timetable carefully and if you wish to choose in-house elective courses, ensure there is no clash in the time slots. Do not choose more than one course from the same slot.
- ❖ Students can refer to the list of NPTEL courses shared by the Academic office and can register for NPTEL elective courses in discussion with Faculty Advisors/HoD..
- ❖ For any queries related to registration, courses/credits etc, students are advised to contact concerned course faculty, FA and Head of the Department.

- iii. For 5<sup>th</sup> and 7<sup>th</sup> Semester Specialization in VLSI students, only the following courses are open to register.  
(a) 25EC5001- VLSI System Design.  
(b) 25EC5000- MOS Modeling for VLSI Circuits.
- iv. For 7<sup>th</sup> Semester Specialization in VLSI students, only the following courses are open to register.  
(a) 25EC5002- VLSI Testing and Testable Design.
