1. In case of students admitted through JoSAA, the Seat Acceptance Fee (SAF) and Partial Admission Fee (PAF) will be adjusted against the Institute fee after deducting the JoSAA processing charges. Similarly, in case of students admitted through CSAB, both the IAF-I + SRPF and IAF-II will be adjusted against institute fee amount after deducting processing charges of CSAB.
2. Accordingly, balance Fee to be paid to IIITDM Kancheepuram by the students admitted to B.Tech or Dual Degree (B.Tech + M.Tech) program through JoSAA and/or CSAB is as follows.

- Students, who apply to both the CSAB special rounds and DASA –CIWG, and get seat allotment through CSAB special rounds, have to pay the balance fee Rs.79,650/- to the institute. (i.e. Total Institute fee:1,42,150 – Amount to be transferred from CSAB to the institute: Rs.62,500 = Balance amount: Rs.79,650/-).
- **Any Differential amount between Institute Fee and the actual amount transferred by JoSAA/ CSAB 2025, is to be paid by the student upon intimation from the Institute after their joining to the institute.**

- Students who have obtained Provisional Seat allotment at IIITDM Kancheepuram through JoSAA and not participating in CSAB special rounds may start paying the above balance fee now onwards. The students who get admission at IIITDM Kancheepuram through CSAB special rounds may pay the balance fee once they opt freeze option in any of the CSAB special rounds.
- Transaction Statement of the above payment must be submitted at the time of physical reporting at the Institute.

3. The Link for student profile creation will be provided tentatively either on 19th or 20th August (after the announcement of CSAB final round seat allotment)

Before arriving at the Institute, the students are required to fill the details and upload the documents through student profile creation link. Students are advised to enter their names exactly as per 10th/SSLC mark sheet so that the same name will appear in their degree certificate later.

- B. Candidates should arrange one set of original documents along with one set of Self-Attested copies of the documents as per Checklist (**Given in Annexure II**) for Document Verification. After submitting the documents, students can proceed to the Exhibition Hall for Document Verification and Institute Admission on a FIRST COME FIRST SERVED basis. Student volunteers from the institute will be available for guidance and support.
