General Discussion:

	Prof. Banshidhar Majhi was appointed as the Director of the Institute by MHRD vide order no. F.No. 48-4/2015-TS.I dated 23.06.2017 on contract basis for a tenure of 5 years from the date of assumption of charge. Prof. Banshidhar Majhi has joined the Institute on 26 th July 2017 on deputation from NIT Rourkela.			
	Prof. Banshidhar Majhi had applied for the post of Vice-Chancellor in Veer Surendra Sai University of Technology (VSSUT), Burla through proper channel and has obtained the approval from the Chairman, Board of Governors for attending the interview at the office of the Governor, Government of Odisha.			

The office of the Chancellor, VSSUT Burla, Rajbhavan Bhubaneswar vide notification no. 6698/SG(HE) dated 28.06.2021 has appointed Prof. Banshidhar Majhi as Vice-Chancellor, VSSUT Burla. In pursuance to the notification, Prof. Banshidhar Majhi has submitted the request for relief on 29.06.2021 from IIITDM Kancheepuram with effect from 31.07.2021 so as to report back to his parent organization (NIT Rourkela) and thereafter to take up the assignment of Vice-Chancellor in VSSUT Burla (Annexure "B").

The agenda was taken up for discussion by the Board and at the commencement of the discussion, Prof. Banshidhar Majhi has informed the Board that he has decided not to accept the offer of appointment and he is withdrawing his request for relief from IIITDM Kancheepuram. The Board agreed with his request. However, before preparation of the minutes of meeting, Prof. Banshidhar Majhi has communicated to the Chairman that he is accepting the offer of appointment of Vice-Chancellor at VSSUT Burla and requested for reconsideration of the decision by the Board.

The Chairman Board of Governors has requested him to submit a fresh request letter for relief from IIITDM Kancheepuram and Prof. Banshidhar Majhi has submitted a request letter on 13.07.2021 for relief from IIITDM Kancheepuram with effect from 12.08.2021(FN) so as to report back to his parent organization (NIT Rourkela) and thereafter to take up the assignment of Vice-Chancellor in VSSUT Burla. (Annexure "C"). The Chairman Board of Governors has convened an extended Board meeting with the members on 13.07.2021 to discuss the fresh request received from Prof. Banshidhar Majhi.

The Board discussed the matter and agreed for the request for relief by Prof. Banshidhar Majhi to take up the assignment of Vice-Chancellor in VSSUT Burla and he may be relieved after serving the notice period of three months in the Institute as per the contract executed by him. The Board authorized the Chairman to forward his request for relief accordingly to the ministry for appropriate action.

The Board also authorized the Chairman to request Ministry for making alternate arrangement for the post of Director till a regular director is appointed to the Institute.

To discuss and approve the Annual Report for the year 2020-21

The Annual Report of the Institute elaborating the activities, achievements and other milestones of the Institute needs to be prepared every year and to be submitted to Ministry of Education (MoE), for laying in the Parliament.

Accordingly, the Annual Report of the Institute for the year 2020-21 is prepared and enclosed as an *Annexure "D"*

To discuss and approve the Annual Accounts for the financial year 2020-21

The Annual Accounts for the year 2020-21 were prepared in the prescribed format and submitted to Director General of Audit (Central) Chennai on 28th June 2021and the audit team has commenced the certification audit from 1st July 2021.

The annual accounts needs to be placed in the Finance Committee and in the Board of Governors for consideration and approval and the approval of the same needs to be communicated to the audit office for the issuance of audit certificate. Further, the annual accounts were placed in the finance committee meeting held on 09.07.2021 and the same was examined and recommended by the Finance Committee. The Annual Accounts of the Institute for the year 2020-21 is placed as **Annexure "E".**

The Board noted the observations of the Finance Committee and instructed the Institute to comply

the same. Further, the Board also directed the Institute for timely completion of the formalities and forwarding the accounts to the ministry so that the same are laid in the Parliament before 31.12.2021.

The Board approved the Annual Accounts for the financial year 2020-21 of the Institute.

BOG-50(2021)-06

To ratify the reduction of hostel fees due to pandemic for the Jul-Nov 2021 semester.

It is submitted that the hostel fees was reduced in the Jul-Nov 2020 and in Jan-May 2021 semester due to Covid pandemic due to second wave the classes are still happening through online mode and No students except some Ph.D students are staying at the hostel. Taking into account the request of the student / parents and also pandemic situations, in case of hostel fee, for the Jul-Nov 2021 it was decided that

For B.Tech. & DD(1st to 4th Year) Students;

- a. To reduce the hostel seat rent from Rs. 3,500/- to Rs. 2,500/- and maintenance charges from Rs. 9,000/- to Rs. 8,000/-.
- b. The advance dining charges amounting to Rs. 14,000/- was not collected.
- c. Establishment charges of Rs. 1,000/- which is in the form of student fund to meet expenditure of cultural events was not collected to avoid celebration of any group event at this juncture.

In view of above action of the Institute, students and parents are not burdened with immediate payment of Rs. 17,000/- during this semester.

As per our estimate, maintenance charge of Rs. 8,000/- per student for the semester would be sufficient to maintain facilities like water treatment plant, STP, Lifts, Housekeeping, security apart from sanitization of hostel and mess building at regular interval

For M.Tech., DD final year and PhD;

The M.Tech. & Ph.D. students are availing fellowship hence they are exempted only the advance dining of Rs. 14,000 and establishment charge of Rs. 1,000/-.

It is submitted that the fee reduction benefit is passed on to students as on roll in the Institute (1400 students). The total financial burden to the hostel will be as under (excluding the Advance dining charges/establishment charges which is collected as advance and paid as per actual and thereby having no impact on the revenue.)

Further it is submitted that there is no change in the collection of tuition fees, and the tuition fees are collected on existing rate as of last year. Further, the matter was placed in the Finance Committee meeting held on 09.07.2021 and the same was examined and recommended by the Finance Committee.

The Board discussed and ratified the action taken by the Institute and noted that this fee reduction is applicable for July-November 2021 semester only.
