- 5. I understand that the continuation of the Award for each semester is contingent on my satisfactory work performance during the preceding semester(s) in the discharge of my responsibilities in teaching and research assignments and my satisfactory academic performance and progress during the preceding Year / Semester in my registered degree programme as assessed by the Doctoral Committee, according to the procedures laid down by the Senate.
- 6.
