#### **General Terms and Conditions:**

- 1. The bids should be valid for 90 days from the due date and this work should be carried out in a time bound manner and the entire work including supplying, installation, testing & commissioning of all the products shall be completed within 30 working days from the submission of contract agreement and security deposit upon receipt of work order.
- 2. The rate shall be quoted in INR.
- 3. No unsolicited correspondence will be entertained after the submission of the offer.
- 4. **Eligibility Criteria:** The bidder must meet the following criteria and submit proof for the same along with the tender document.
  - Valid proof of Firm registration / Business License.
  - Should have executed similar "Electrical works experience" preferably awarded by the State Govt. / Central Govt. / Autonomous / Reputed corporate institutions / Organizations, for the value enlisted below and executed on or after 01/01/2020 and Work Order / PO copy to be enclosed.

- 5. Bidders shall deposit EMD through SBI E'Collect/ for to avail EMD exemption, bidder shall submit the valid proof of MSME certificate. In the case of EMD, the amount must be paid through online mode and it shall be received on or before the last date and time of bid submission and the payment proof of EMD shall be attached along with the bid.

- 7. For the successful bidder, the EMD will be retained as security deposit and will be released after the satisfactory completion '1' year defect liability period. In the event of any damages to the Institute / failure to execute the work, the cost of repairs will be deducted from the security deposit.
- 8. For the unsuccessful bidders, EMD amount will be refunded within 30 days from the date of issue of work order.
- 9. The bidder shall enclose cancelled Cheque/bank details to refund the EMD amount in case of unsuccessful bids.
- 10. EMD shall be forfeited if any tenderer with draw their offer with in the bid validity period.

11. Quantity mentioned in the technical compliance sheet may subject to vary.

- 13. Quoting merely the lowest price does not confer any right to any bidder for award of work order. The Institute reserves the right to select any bid on the grounds of quality, offer of additional/special features, compatibility, etc.
- 14. The Institute also reserves the right to reject any bids with sub-standard products even if they are found to be lowest.
- 15. Any delay in executing the work on the time and date mentioned above will lead to the total rejection of the work and no payment whatsoever shall be made towards the work.
- 16. No damage shall be made to any fittings, surfaces, paintings of the building. If any made shall be restored by the vendor at his own cost.
- 17. The rate quoted should be inclusive of all men, material, transportation and installation of the items at the designated place as per the directions of the Engineer-In-Charge.
- 18. Special concession in rates if any applicable for Educational Institution shall also be offered and indicated clearly.
- 19. The tenders will be opened by a Committee of the Officers of IIITDM Kancheepuram. The tenderer or their authorized representatives may attend the time of opening of the tenders.
- 20. The Institute also reserves the right to increase or decrease the scope of work by any margin depending on the requirement. For any dispute, the Institute shall be the final authority and its decision shall be final and binding on both the parties. The Institute reserves all rights to accept or reject any or all tenders in part or full without assigning any reason thereof.
- 21. The institute also reserves the right to accept the TENDER in full or partially for some of the items quoted by deleting certain items without assigning any reason thereof.
- 22. Work shall be executed and completed as per the technical terms and conditions of this document as per the direction of Engineer in charge.
- 23. The successful bidder shall be required to sign a detailed contract agreement with IIITDM Kancheepuram within a period of 07 working days after the submission of Security Deposit.
- 24. The site is ready for handing over immediately upon submission of security deposit (SD) and contract agreement.
- 25. The work shall be executed and completed within "30 working days" from the date of Commencement of the Work. In case, the Contractor fails to complete the assigned work within specified Work Completion Period, IIITDM Kancheepuram may recover Liquidated Damage

- and/or terminate the Contract and/or forfeit the Security Deposit. IIITDM Kancheepuram on its part would be required to handover the site to the Contractor free from any encumbrance.
- 26. The Contractor shall at his own expense arrange for the safety provisions as appended to these conditions or as required by the Engineer-in-Charge, in respect of all labor directly or indirectly employed for performance of the works and shall provide all facilities in connection therewith.
- 27. The Contractor shall be responsible for providing constant and adequate supervision of the work to ensure compliance with the provisions of laws relating to safety and for taking all practical steps necessary to prevent accidents.
- 28. Required materials brought by the contractor shall be stored only at places as designated by the Engineer-in-Charge. Storage and safe custody of material shall be the sole responsibility of the contractor. The contractor shall ensure that no materials/ wastes/ equipment's are dumped at site. Proper cleaning and debris removal should be done on daily basis
- 29. The material to be used by the Contractor should be conforming to reputed brands or ISI marks. Samples of all materials / fixtures as specified in 'Techno-Commercial bid' shall be got approved before their use by the Contractor. Catalogues / Brochures & product warranty certificates shall be submitted to the Engineering-In charge of the Institute as required.
- 30. After the execution of work, the contractor shall submit the actual drawings indicating wiring diagram from end to end point including looping, switches, sockets, MCB, etc.
- 31. IIITDM Kancheepuram has Power to issue instructions etc., from time to time issue besides Drawings if any, in regard to:
  - i. Minor addition, reduction, omission or substitution of any work included in the Contract.
  - ii. Minor variation in the dimensions of any part of the works.
  - iii. Minor discrepancy in the Drawings if any, or between the Bill of Quantities and / or Specification.
  - iv. The removal from the site of any material brought thereon by the Contractor & the substitution of any other material.
  - v. If any person deputed by the contractor found guilty / misconduct / not performing the duty, IIITDM has a right for a dismissal of the person/(s) from the works, the contractor has to replace the another suitable person within a given time frame at without any additional cost to IIITDM Kancheepuram.
  - vi. The opening up of or inspection of any work covered up, all other instructions issued to him covering other aspects of the Contract.
  - vii. Execution of wiring bare joints in wires and cable are not allowed. Under extra ordinary conditions Terminal blocks with required safety measures must be used instead of joints without any additional cost.
  - viii. During the execution any wall/ flooring/ table cutting and finishing (providing hy-lam sheets/dummies/cement concreate etc.) also to be carried out without any additional cost.

- 32. No compensation shall be payable to the contractor for any damage caused by rains, lightening, wind, storm during the execution of work. He shall make good all such damages at his own cost; and no claim on this account will be entertained.
- 33. In case the Contractor fails to complete the assigned work within specified Work Completion Period, IIITDM Kancheepuram may recover Liquidated Damage and/or terminate the Contract and/or forfeit the Security Deposit. IIITDM Kancheepuram on its part would be required to handover the site to the Contractor free from any encumbrance.
- 34. The payment shall be made as first and final bill on completion of the work satisfactorily. Any less usage of number of items, the rate will be reduced pro-rata and vice versa.
- 35. Payment of bills shall be made against supply, acceptance and after verification of the bill by the Institute after deduction of taxes and TDS as per applicable rules. The Final bill shall be submitted by the contractor after the execution of work. Payment to be made only for the work actually done.
- 36. The Contractor shall take at his own cost, necessary insurance cover in respect of staff and other personnel to be employed or engaged by him in connection with the afore mentioned services personnel by services to be rendered.
- 37. The work is to be executed as per directions of Engineer in charge of IIITDM.
- 38. All necessary safety precautions shall be taken during work execution & operation at site by the bidder.
- 39. Quantities, requirements and specifications given are approximate and may vary as per site conditions and few items may be deleted / added / modified, if needed.
- 40. Rate must be quoted on unit basis (including transportation, labour, installation etc.) in the price schedule only and taxes (if any) should be clearly indicated.
