# **Eligibility and Criteria for Selection:**

A firm or agency satisfying all the following conditions.

- Having experience of at least two years in selling medicines. (Copy of incorporation certificate to be enclosed)
- The contractor should have a valid license to sell, stock, exhibit or offer for sale, or distribute drugs.

#### **GENERAL TERMS AND CONDITIONS FOR TENDER**

- i. Prescribed tender form can be downloaded from IIITDM website <u>www.iiitdm.ac.in</u>.
- Tender should be in a sealed envelope superscripted "Tender for supply of medicines "addressed to the Registrar, IIITDM Kancheepuram, Melakottaiyur, Chennai 600127.
- iii. IIITDM Kancheepuram, reserves the right to award the contract to deserving parties either in full or in parts. The decision of IIITDM Kancheepuram is final and unquestionable.
- iv. The contract is for initially for a period of one year and extendable upon satisfactory service at the discretion of institute.
- v. The contractor shall not assign or sublet the work or any part of the work to other persons or party.
- vi. The contractor shall compensate IIITDM Kancheepuram for any loss or damage to the Institute /property, material of IIITDM Kancheepuram due to his workmen/ representatives' negligence or otherwise during execution of work contract.
- vii. IIITDM has the right to reject/terminate the contract without assigning any reason.

#### ix. PRICES

The cost of medicines should include all packing, incidental charges and delivery at IIITDM Kancheepuram.

Prices are inclusive all taxes.

### x. SUPPLY OF MEDICINES / MANUFACTURER

The vendor must supply and deliver all the indented medicines; and of the manufacturer mentioned against each medicine only and medicines supplied other than the indented ones will not be accepted". The contract will be cancelled if they fail to comply with the above and the clause of Liquidated damages will be imposed. Under exceptional cases/circumstances, prior permission may be sought from the OIC, Health Centre for non-availability of indented medicines.

### xi. EXPIRY DATE

The supplied goods should be from the latest stocks and medicines should have minimum Oneyear expiry period.

### xii. ANNUAL RATE CONTRACT PERIOD

Annual Rate Contract is for One (1) year. However, it may be extended one more year on mutual consent.

Discount: Highest discount offered may be mentioned / specified

Due date: Tenders received after the specified due date will not be considered/entertained.

- xiii. **Awarding of contract:** After, awarding of contract for a specified period, vendor is bound to supply all the medicines in the indent allowing discount as quoted.
- xiv. # SPECIAL CONDITIONS OF CONTRACT

You are, therefore, requested to submit your tender document as per the terms and conditions given below:

1. No advance payment is permissible. However, payment will be made after supply of medicines as per Purchase Order and due acceptance / certification of the medicines by the OIC, Health Centre / Medical Consultant, IIITDM Kancheepuram.

2. The discount offered shall be valid for a period of ONE YEAR from the date of acceptance of the tender or till the expiry of the contract.

3. Purchase Orders will be placed separately for each individual medicine from time to time as per the requirement.

4. The supplier should be in a position to deliver the medicines / material within one week from the date of confirmed purchase order. The supplier will indicate batch number, name of the manufacturer, date of expiry of drugs indented in the relevant column of the indent sheet at the time of supplying the medicines.

5. Medicines supplied should have minimum of ONE-year expiry period. Sufficient stock of standard quality of medicines at all times have to be maintained to avoid inconvenience to the Academy beneficiaries.

6. The medicines to be supplied shall be of standard quality and in case, it is found that the medicines is expired or near the date of expiry, found not of standard quality, substandard or spurious, supplier will be debarred for a period of three (3) years besides other legal action that may be initiated against them as per law. The supplier will ensure that the medicines are transported and supplied to the Health Center of the Institute while maintaining the conditions as specified.

7. The supplier should agree exchange the medicines with extended expiry date, in case desired by our Medical Officer as and when required.

8. The supplier shall execute an AGREEMENT on non-judicial stamp paper worth of Rs.100/- with due signatures etc.

9. Director, IIITDM reserves the right to accept or reject any of the offers either in part on in full without assigning any reason thereof and the decision of the Director, IIITDM on any dispute will be final and legally binding. If any disagreement or dispute arising in connection with the contract, the same shall be settled under the Court of Law within its jurisdiction at Chengalpattu. The resultant contract will be under Indian Laws.
