# 2. Earnest Money Deposit:

- 2.1 Bidders shall Deposit EMD through SBI E'Collect. The amount must be paid through online mode and it shall be received on or before the last date and time of bid submission and the payment proof of EMD shall be attached along with the technical bid. Physical mode of payment i.e. Banker cheques or Demand drafts are not acceptable.

- 2.3 In the case of payment failure/ mismatch of particulars leads to cancellation of bid.
- 2.4 For the successful bidder, the EMD will be retained/ adjusted against the security deposit.
- 2.5 For the unsuccessful bidders, EMD amount will be refunded within 30 days from the date of issue of work order.
- 2.6 The bidder shall enclose cancelled Cheque/bank details to refund the EMD amount in case of unsuccessful bids.
- 2.7 EMD shall be forfeited if any tenderer with draw their offer with in the bid validity period
- 2.8 Valid proof of MSME exemption shall be uploaded for to waive off the EMD.

#### 3. Security Deposit & Contract Agreement:

- 3.1 On receipt of notification of award, successful bidder shall complete the following within 07 working days:
- 3.1.1 Submission of Security Deposit 5% of Contract value in the form of a Crossed Demand Draft/Pay Order/Banker's cheque/FDR drawn/Bank guarantee in favor of "The Registrar, IIITDM Kancheepuram", payable at Chennai. within 07 (seven) working days of the receipt of Notification of Award (NOA) / Award of work order from IIITDM Kancheepuram (The Defect Liability Period as specified (ie:12 Months after completion of work)
- 3.1.2 The successful bidder shall be required to sign a detailed contract agreement & commence he work within 07 working days from the date of receipt of work order in 100 Rs. - 3.2 In case of failure to commence the work by the Contractor within 07 days after signing of the contract or handover of site, the Institute shall be at the liberty to terminate the Award and forfeit the Security Deposit.

# 4. Preparation of bids - Two bid system (simultaneous receipt of separate technical and financial bids):

- **4.1** Technical bid shall consist of prequalification forms along with supported documents as detailed below:
  - 4.1.1 Complete prequalification papers, Name of the Agency and also commercial terms etc., offered (Note: Price column in this cover should be kept blank).
  - 4.1.2 Duly filled and digitally signed Bid submission & self-declaration Proforma (As per Annexure 1), EMD transaction details/ MSME exemption certificate, Cancelled cheque/ Bank details & GST Certificate.
  - 4.1.1 Duly filled and digitally signed copy of Technical Qualification Proforma along with copy of work order(s) & it's work completion certificate(s) as per the eligibility criteria referred in clause no. 1.
- **4.2** Financial bid/Techno commercial bid indicating item-wise price for the items mentioned in the technical bid, special concession in rates if any applicable for Educational Institutions shall also be offered and indicated clearly.
- 4.3 Both the covers should be submitted through online CPP portal <u>https://eprocure.gov.in/eprocure/app</u> before due date and time.

### 5. Technical terms:

- 5.1 The selected contractor will have to carry out "Design, supply, installation, testing and commissioning of Audio-Video system works at senate hall", which have been listed under the 'Techno-Commercial Bid' of this tender document. He shall be under obligation to carry out all of the works stipulated in the contract.
- 5.2 The materials used by the Contractor shall be of reputed make. The contractor shall ensure that all the materials / fixtures specified in Techno-Commercial Bids shall be preapproved before their use by the Contractor. Catalogues / Brochures /Warranty Certificates if any are also to be submitted to this office by the Contractor along with samples whenever required.
- 5.3 The work shall be carried out as per the relevant CPWD general specifications for civil and electrical works & Indian Electricity rules 1956 as amended up to date.
- 5.4 After the execution of work, it shall be proof checked by the contractor in real time for a minimum period of 10 days, during the period, the system efficiency will be counter checked by the institute's Engineering-in-charge as required.
- 5.5 During the execution of work, the selected contractor shall follow all safety measures and protocols time to time laid by the institute and the contractor shall coordinate with other contractors for smooth functioning of Institute activities as required.
- 5.6 IIITDM Kancheepuram has Power to issue instructions etc., IIITDM Kancheepuram may in its absolute discretion & from time to time issue further Drawings if any, &/or written instructions, detailed directions & explanations in regard to:
  - 5.6.1 Minor addition, reduction, omission or substitution of any work included in the Contract.
  - 5.6.2 Minor variation or modification of the design, quality, character of any work.
  - 5.6.3 Minor variation in the dimensions of any part of the works.
  - 5.6.4 Minor discrepancy in the Drawings if any, or between the Bill of Quantities and / or Specification.
  - 5.6.5 The removal from the site of any material brought thereon by the Contractor & the substitution of any other material.
  - 5.6.6 The dismissal from the works of any person employed there-upon by the Contractor to carry out the work under the provisions of this Contract and its replacement by another suitable person within a given time frame at no additional cost to IIITDM Kancheepuram.
  - 5.6.7 The opening up of or inspection of any work covered up, all other instructions issued to him covering other aspects of the Contract.
  - 5.6.8 Execution of bare joints in cables are not allowed. Under extra ordinary conditions Terminal blocks with required safety measures must be used instead of joints without any additional cost.

- 5.6.9 During the execution any wall/ flooring/ table cutting and finishing & making good (providing hy-lam sheets/ dummies etc.) also to be carried out without any additional cost.
- 5.7 The requirements given in the 'Techno-commercial bid' are only indicative and not exhaustive. Contractor shall be required to complete the project. The decision of IIITDM Kancheepuram authorities in this regard shall be final and binding on the Contractor.
- 5.8 Engineer-in-charge or any other representative/official deputed by the IIITDM Kancheepuram shall have the right to inspect or to test the materials to establish their conformity to the ordered specifications. The Contractor shall provide all reasonable facilities and assistance to such representative without any charges to the IIITDM Kancheepuram in this regard.
- 5.9 Further, IIITDM Kancheepuram may direct the Contractor to get any/all materials/samples tested from specified organization(s) for conforming to the tendered specifications at the cost of the Contractor. In case, any inspected or tested material fails to conform to the ordered specifications, or workman ship is found to be unsatisfactory, IIITDM Kancheepuram may reject them and Contractor shall either replace the rejected material or make alternative arrangements necessary to meet the stipulated specifications and rectify the defects pointed out in the workman ship, at no additional cost to IIITDM Kancheepuram.
- 5.10 Work shall be executed and completed as per the technical terms and conditions of this document. In case the Contractor fails to complete the assigned work within specified Period, IIITDM Kancheepuram may recover Liquidated Damage and/or terminate the Contract and/or forfeit the Security Deposit. IIITDM Kancheepuram on its part would be required to handover the site to the Contractor free from any encumbrance.

#### 6. Commercial terms:

- 6.1 The work shall be executed and completed within **30 working days** from the date of Commencement of the Work. In case, the Contractor fails to complete the assigned work within specified Work Completion Period, IIITDM Kancheepuram may recover Liquidated Damage and/or terminate the Contract and/or forfeit the Security Deposit. IIITDM Kancheepuram on its part would be required to handover the site to the Contractor free from any encumbrance.
- 6.2 Item Rates quoted on the 'Techno-Commercial Bid" by the bidder shall be valid and constant during the entire period of contract and will not be subject to any variation on any account whatsoever.
- 6.3 Measurements of all items having financial value shall be recorded in Measurement books so that a complete record is obtained of all works performed under the contract. Measurements shall be taken jointly by the IIITDM Kancheepuram official designated for the purpose and the Contractor.
- 6.4 Payment of bills shall be made against supply, acceptance and after verification of the bill by the Institute after deduction of taxes and TDS as per applicable rules. Running account bill/Final bill shall be submitted by the contractor after execution of work and completion certificate shall be furnished by the Institute after completion of work in full. Payment to be made only for the work actually done.

- 6.5 The Contractor shall take at his own cost, necessary insurance cover in respect of staff and other personnel to be employed or engaged by him in connection with the afore mentioned services personnel by services to be rendered.
- 6.6 The defect liability period is of one year for all the items. Further, the products manufacturer's warranty certificates shall be submitted to the Engineer-In-Charge.
- 6.7 Statuary deductions of taxes at source will be carried out from the payment due at the prevalent rates as prescribed by the government.

#### 7. Other conditions:

- 7.1 The institute reserves the right to reject any or all the bids without assigning any reasons thereof. No tenderer shall have any cause of action or claim against IIITDM Kancheepuram for rejection of his bid.
- 7.2 The IIITDM, Kancheepuram is having a right to cancel the awarded work at any point of time in case of the contractor's performance is not up to the mark by giving termination letter.
