- 2. The intending quotationers may inspect the items at site on 07.12.2022.
- 3. The sale will be finalized in favor of the highest quoted bidder, whereas, final decision is reserved to the IIITDM Kancheepuram to accept the offer in full or in parts or reject the offer summarily or partly without assigning any reasons
- 4. Bidder shall ensure that, it is mandate to quote all the items, quoting partly or non-submission of required documents will be summarily rejected.

- 5. GST extra as applicable.
- The successful bidder shall deposit the balance amount of bid in full after deducting the EMD of Rs. 20,000/- (Rupees twenty thousand only) on or before 05 days from the date of receipt of work order.
- 7. After the award of contract, in the event of failure of a successful bidder to comply with the conditions referred, is liable to be cancelled and re-auction will be held and the amount deposited as caution deposit will be forfeited.
- 8. No Proxy in bidding is permitted.
- 9. The successful bidder shall shift the material within 10 working days from the receipt of work order.
- 10. The material shall be shifted by the successful bidder from wherever it is with in the campus for which no extra amount will be paid. During shifting, if any damages to the building or any institute property, the damages shall be borne by the successful bidder from his own cost.
- 11. While removing the scrap material from the yard, necessary precautions shall be taken to ensure the safety of the labourers.
- 12. The quantities mentioned above are approximate, the actual quantity shall be measured while taking out the material from the campus and amount will be worked out. If any excess cost over the bid amount shall be deposited by the successful bidder. If the actual quantity is less than the referred quantity, necessary cost reduction will be worked out and refunded to the successful bidder.
- 13. The tender document is non-transferable and Conditional Tenders / Non-compliance of any of the conditions set in tender document shall render the bid liable for rejection.
