## **TERMS & CONDITIONS GOVERNING THE CONTRACT**

- **1. Eligibility Criteria:** In order to be considered for the contract of the works as detailed under `Technical Bid' in this Tender Document the Firm/tenderer shall:
  - 1.1 Have a corporate or works office at Chennai and valid certificate/ proof shall be submitted.
  - 1.2 Have experience in executing similar works "shall mean experience in execution of similar type German Structure Hanger sheds with Civil & Electro-mechanical works, furniture arrangement, stage decoration, air conditioning, interiors & furnishings for VVIP meetings etc.," and awarded by the State Govt. / Central Govt. / Autonomous / Reputed corporate institutions / Reputed associations, for the value enlisted below and executed on or after 01/01/2018.
    - (i) Rs. 48.50 lakhs Excl. GST for a single work order (Or)

The bidder shall produce a valid documentary proof for Work order / Work completion certificate from the scheduled works mentioned.

## 2. Earnest Money Deposit/Bid Declaration Form:

Instead of EMD, Bidders are to execute a Bid declaration form accepting that if they withdraw or modify their Bids during the period of validity or if they fail to execute the awarded work as per the work order/contract they will be debarred for the period of one year for bidding for any tender of the institute. Further, the debarment will be intimated to all Institute of Government of India/ Governmental organizations for bidding by the firm for any tender (Declaration format enclosed as Annexure-1).

## 3. Security Deposit & Contract Agreement:

- 3.1 On receipt of notification of award, successful bidder shall be required to accept & acknowledge the work order within 03 working days.
- 3.2 Successful Bidder shall submit the Security Deposit of 3% of Contract value in the form of a Crossed Demand Draft/Pay Order/Banker's cheque/FDR drawn/Bank guarantee in favor of "The Registrar, IIITDM Kancheepuram", payable at Chennai within 07 (SEVEN) working days of the receipt of Notification of Award (NOA) / Award of Work order from IIITDM Kancheepuram
- 3.3 The successful bidder shall be required to sign a detailed contract / agreement with IIITDM Kancheepuram within a period of 07 working days from the date of receipt of work order and commence the work with in this period of 07 days.

## 4. Pre-Bid meeting:

4.1 For better appreciation of works mentioned under this contract, the bidders are advised to inspect and examine the site and satisfy themselves before submitting their bids. The tenderer shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A tenderer shall be deemed to have full knowledge of the site whether he/she inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. Submission of bids by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and local conditions and other factors having a bearing on the execution of the work.

#### 5. Preparation of bids - Two bid system (simultaneous receipt of separate technical and technocommercial bids):

- **5.1 Technical bid** shall consist of only prequalification document along with supported documents shall be uploaded as detailed below:
  - 5.1.1 Complete prequalification papers, Name of the Agency and commercial terms etc., offered (Note: Price column in this cover should be kept blank).
  - 5.1.2 Duly filled and digitally signed Bid submission, bid declaration & self-declaration Proforma (As per Annexure 1).
  - 5.1.3 Duly filled and digitally signed copy of qualification proforma along with a copy of GST certificate, Proof/correspondence for corporate / works office at Chennai, Registration certificate & work order / work completion certificate as per the eligibility criteria referred in clause no. 1.
- **5.2** Techno-commercial bid indicating item-wise price for the items mentioned in the Annexure-3, special concession in rates if any applicable for Govt. Educational Institutions shall also be offered and indicated clearly.
- 5.3 Both the covers should be submitted through online eWizard portal <u>https://mhrd.euniwizarde.com</u> before due date and time.

#### 6. Technical terms:

- 6.1 The selected contractor will have to execute convocation related works at IIITDM, Kancheepuram, which involves "Installation and un-installation of German Structure including Civil & Electro-mechanical works, furniture arrangement, stage decoration, interiors & furnishings etc. as detailed. The contractor shall have or obtained the required valid state/central Govt. license / certificates to carry out the work. No additional costs will be paid in this regard.
- 6.2 The German Hanger Shed should be of rigid, water proof and shall follow the fire protection norms.
- 6.3 Provision of ladder / scaffolding / crane / any other required machinery with suitable capacity to hold the German Hanger structure of size as proposed against uplifting, toppling due to winds, rain etc., shall be made.
- 6.4 The German hanger structure walls, carpets and all other connected accessories shall be of newly looked and unused and which shall be dust free and stain free.
- 6.5 All the Electrical lines & equipments installed by the agency from Diesel Generators to the German structure as per the required load. Proper care shall be taken for the cables, switch boards, panels, etc., from DG to Structure/load points throughout the event.
- 6.6 The Agency shall be responsible to ensure complete safety of men & materials. Mobile DG sets, which should be in good condition & sound proof, which includes DG operator / Mechanic / Technician / Electrician, Diesel for DG set operation during entire Convocation program and suitable cable of required length along with Distribution Panel/DB with suitable protection switchgear and all required accessories. Required no. of separate Neutral and Body earthing pits /points included in the scope of work. Note: DG set should be used during Convocation shall run for an approximate time duration of 06 hours as required.

- 6.7 All edges and sides of the main dais and other stages, joining of plywood & Jockeys should be even without any undulations and jerk free. The Dais shall be strong enough and the design shall be in such to take the upcoming live load of 50 members weight, chairs, tables, Teapoy & podium etc.,
- 6.8 Water and electricity will be provided free of cost for the said period.
- 6.9 Setting up of Ultra High Definition Resolution of mentioned sizes of LED screen / wall panel with all required supports, cables and all accessories including testing & operation in good condition for the entire program.
- 6.10 Setting up of good quality professional Audio & Video systems on the stage and in and around the Convocation venue covering all locations taking care of echo elimination with all required accessories.
- 6.11 Setting up of Air Conditioning System inside the Convocation hall covering all locations, providing tower AC's (indoor Unit) especially on Stage area covering all Guests/VVIPs on stage and suitable Indoor units (Duct-able/blower/etc.) covering entire seating/gallery/media stage/entrance, with required electrical arrangements etc.
- 6.12 Setting up of green room (western style) using new & good quality of materials as per the directions of Engineer-in-charge.
- 6.13 All the Civil & Electrical works should be carried out as per the CPWD norms, state & central specifications and modifications shall be executed as per the directions of the Engineer-in Charge.
- 6.14 The quantities mentioned in the BOQ are tentative (i.e. based on past experience) and which may vary depends upon on site conditions.
- 6.15 As the Convocation event is scheduled tentatively on 10-09-2022, the all specified arrangements shall be made as per the tentative scheduled mentioned below.

- 6.16 The Payment shall be made as per the actual measured quantities of the items as specified in the agreement.
- 6.17 The agency has to clear the site within two days after completion of the event and unwanted materials/wastes etc., should be cleared from the site.

6.18 The contractor shall ensure to provide the good quality ISI electrical cables, switch gears, panels, lighting arrangement, serial lights, Audio, video system and other equipments to avoid the unwanted incidents. Bare joints should be avoided.

## 7. Commercial terms:

- 7.1 The bidder is requested to enter their rate/price in the prescribed cell at Annexure 3.
- 7.2 The work shall be carried out with least hindrance to the adjoining buildings and offices and the contractor will be responsible for any damage, caused to the existing fixtures, electric fittings, cables, roads, pipelines etc. in the course of execution and the contractor shall make good any such damages for which nothing extra is payable.
- 7.3 If the Contractor fails to perform or complete the works effectively and efficiently during the period as per the work order, the competent authority will evaluate the incomplete work/delayed work and take appropriate decision for penalty/liquidity damages. In addition to it, Institute shall be at the liberty to terminate the Contract, and/or forfeit the Security Deposit, in case, Contractor fails to complete the assigned work as per the given time line.
- 7.4 The Contractor shall take at his/her own cost, necessary insurance cover in respect of their staff and other personnel to be employed or engaged by him in connection with the afore mentioned services personnel by services to be rendered.
- 7.5 Statuary deductions of taxes at source will be carried out from the payment due at the prevalent rates as prescribed by the government.

## 8. Other conditions:

- 8.1 The institute reserves the right to reject any or all the bids without assigning any reasons thereof. No tenderer shall have any cause of action or claim against IIITDM Kancheepuram for rejection of his bid.
- 8.2 The IIITDM Kancheepuram reserves right to withdraw / relax any of the terms and conditions mentioned above so as to overcome the problem encountered by the contracting parties.
- 8.3 The IIITDM Kancheepuram reserves the right to terminate the contact at any time without assigning any reasons by giving a notice to the contracting agency/firm/company.
- 8.4 The tender document is not transferable and Conditional Tenders / Non-compliance of any of the conditions set in tender document shall render the bid liable for rejection.
- 8.5 IIITDM Kancheepuram reserves the right to seek any clarification from the bidders or waive any minor deviation in the provisions governing the contract at its sole discretion.
- 8.6 IIITDM Kancheepuram reserves the right to suitably increase or reduce the scope of work/ bill of quantities mentioned in this tender. The payment will be made correspondingly as per the actual quantity executed.

## 9. Special Conditions:

9.1 The contractor shall ensure to carry out the work execution apar with the safety norms & precautionary measures framed by the Govt. authorities & IIITDM time to time. The selected contractor shall keep necessary markings / identifications such as WORK IN PROGRESS & DANGER PLATES etc., wherever required in terms of safety.

- 9.2 The contract shall include supplying of scheduled material, manpower, tools and tackles like ladder, stools, spanners, testing equipment, special equipments, cranes, jockeys, etc.
- 9.3 The selected contractor shall ensure that the persons deployed are disciplined and vigilant in performance of their duty. The tenderer shall engage medically and physically fit persons. The tenderer must employ adult labour only. Employment of child labour will lead to termination of contract.
- 9.4 All the manpower deputed by the selected contractor shall wear safety helmet, Safety shoe, safety hand Glove, Nose mask and other safety Personnel Protective Equipments (PPEs) as per standards with identification badge/ID card issued by the Contractor.
- 9.5 The contractors' personnel shall not disclose any information/records or drawings furnished to him by IIITDM. Any drawings, records and other information prepared by the contractor or by IIITDM or jointly by both for the execution of the work shall not be disclosed without the prior approval of the IIITDM.
- 9.6 The contractor shall keep his work spot and surroundings neat, clean and tidy. It should be free from dust, rubbish, scrap, surplus materials and unwanted tools and equipments. The Engineer in charge or his authorized representative has the right to stop the work, if the contractor fails to improve upon the house keeping after having been notified.
- 9.7 Engineer in charge will have the right to withdraw the work permit for any of the workmen for reasons of misconduct, incompetence in work, violation of safety and fire rules, negligence on duty etc.
- 9.8 Contractor should ensure availability of his representative throughout the event who shall be responsible for manpower availability and smooth functioning of the event.
- 9.9 Any person authorized by the competent authority shall be at liberty to carry out the checks on work quality and persons deployed by the contractor.
- 9.10 The Contractor shall employ its labour in sufficient numbers to maintain the required rate of progress and ensure the quality of work.
- 9.11 Restrictions may be imposed by the institute security staff or department etc., on the working and for movement of labour, materials etc. The contractor shall be bound to follow all such restrictions/ instructions and nothing extra shall be payable on this account.
- 9.12 At the work site, necessary first aid arrangements shall be made available by the contractor on his own as per relevant norms.
