Item No.2	To Approve the Revised Estimate 2015-16 & Budget Estimate 2016-17	
	MHRD had sanctioned a budget of Rs.60.00 Crores as Grant in Aid for the year 2015-16. The Budget proposals viz. Revised Estimate for 2015-16 and Budget Estimate 2016-17 have to be communicated to the Ministry for Grants from Govt of India.	
Resolution 03/2015	The infrastructure development is in full swing and the works are under various stages of completion. Considering the requirement of funds obtained from CPWD and others, the Revised Estimate for the Financial Year 2015-16 is proposed at Rs.83.01 Crores. (Capital Budget Rs.67.96 Crores and Revenue Budget of Rs.15.05 Crores). Similarly the Requirement for the Financial year 2016-17 is proposed at Rs.177.80 Crores (Capital Rs.154.95 Crores and Revenue Budget Rs.22.85 Crores).	
	The Committee wanted to know the expenditure incurred towards setting up and running IIIT Kurnool in the IIITDM Kancheepuram campus and advised the Institute to keep the IIIT Kurnool accounts separately as a project account so that the same can be submitted to Ministry on demand.	
	The Committee after detailed deliberation RESOLVED to recommend to Board for approval of the Revised Estimate 2014-15 and Budget Estimate 2015-16. (Annexure 'A').	
Item No.3	To report about the Revised Estimate 2015-16 and Budget Estimate 2016-17 for IIIT Kurnool	
	IIITDM Kancheepuram has been made as the mentor Institute for the newly created IIIT Kurnool and student admission for the B.Tech Programme of IIIT Kurnool has been completed. The classes are presently being held in IIITDM Kancheepuram campus. IIITDM Kancheepuram has been entrusted with the responsibility of establishment of IIIT Kurnool and the preliminary work of identification of land, topographical survey, architectural planning for initial batches (2015 & 2016 batches) etc. has been completed. The development of the infrastructure of IIIT Kurnool is underway in high pace to operate the Institute at its
