The Institute had made a presentation about the high lights of the annual accounts of IIITDM Kancheepuram and IIITDM Kurnool for the financial year 2017-18. The Institute explained about the non receipt of capital grants for the last two years in respect of IIITDM Kancheepuram and pending infrastructure works at IIITDM Kancheepuram. The committee enquired about the arbitration liability shown in the annual accounts. It was explained that the same could not be made due to want of funds. The committee requested the MHRD member for needful action for early release of funds.

FC 26 (2018)-4	WP No.16450/2018 & 16451/2018 in High Court of Madras filed by M/s. GMS Elegant Builders (I) (P) Ltd., Erode for pending payment towards Construction of Faculty Quarters
	The Institute had accorded Administrative Approval and Expenditure Sanction



(AA&ES) to CPWD for construction of Faculty Housing at a cost of Rs.38,91,35,000/-. The Institute had entered a MoU with CPWD and as per the terms of MoU the Institute had released an amount of Rs.13,23,66,113/- as on 13.06.2016. The CPWD is executing the work through M/s. GMS Elegant Builders (I) (P) Ltd., Erode in two works namely

- 1. Construction of Faculty Block Phase I.
- 2. Construction of Faculty Block Phase II (Eastern Block).

The CPWD is executing the works and the payments are released by them through running account bill. Now, M/s. GMS Elegant Builders (I) (P) Ltd., Erode has filed a Writ petition vide Writ Petition No.16450 of 2018 & Writ Petition No.16451 of 2018 in High Court of Madras against 1. The Secretary (Finance & Expenditure), Ministry of Finance, Government of India, New Delhi (R1) 2. The Director (Expenditure), Ministry of Finance, Government of India, New Delhi (R2) 3. The Secretary, MHRD, Government of India, New Delhi (R3) 4. The Director, IIITDM Kancheepuram, Chennai (R4) 5. The Director General (Works), CPWD, New Delhi (R5) 6. The Chief Engineer (SZ), CPWD, Chennai (R6) 7. The Project Manager, IIITDM Project Circle, CPWD, Chennai (R7) 8. The Executive Engineer (KPD II), CPWD, Chennai (R8) praying intervention of the court for release of pending payment towards construction of faculty quarters.

As per the petition, the petitioner is having pending payment of Rs.7.29 crores and in this regard, the agency approached CPWD, Ministry of Finance, MHRD and others. In response, CPWD replied that "they have already requested the client department for release of balance funds for the above work, but till today we have not received any funds from IIITDM Melakottaiyur. Hence we could not pay the running account bill. MHRD, in its response to the agency stated that "the funds for construction activities undertaken at IIITDM Kancheepuram cannot be released till the revised cost of Institute Project gets finalized".

The agency submitted to the court that "the respondents are not justified in refusing to release the payments" and prayed intervention of the court to direct the respondent to release the payment.

The matter came up for hearing before the Hon'ble Judge on 04.07.2018 and the notice is issued by the court for reply to the respondents returnable within

four weeks. The next hearing of the case is scheduled on 01.08.2018.

The Institute proposes to engage Shri. Karthikrajan, Advocate (the lawyer who is representing the Institute in other cases).

The Finance committee noted the same.
