GENERAL TERMS AND CONDITIONS

1. The tender floated for the water requirement is for '3' months. If required, the Institute has the liberty to extend the period for a further '3' months at the same rate, terms and conditions.
2. The successful bidder must submit a security deposit in the form of a Demand Draft or Bank Guarantee, which will be released after '1' month from the satisfactory completion of the water supply through tanker lorries. In case of any damage to the Institute or failure to perform the job, the cost of repairs or penalties will be deducted from the security deposit.
3. After receiving the Purchase Order, the quantity of water shall be delivered daily as per the requirement specified by the Engineering in Charge.
4. The quoted rates shall be valid for 90 days from the last date of bid submission and the price shall be quoted in INR.
5. Unsolicited correspondence is not entertained after the submission of the offer.
6. Quoting merely the lowest price does not confer any right to any bidder for award of supply order. The Institute reserves the right to select any bid on the grounds of quality, offer of additional/special features, compatibility, etc.
7. The Institute also reserves the right to reject any bids with sub-standard products even if they are found to be lowest.
8. Further, the Institute has a right to cancel the purchase/work order at any point of time without assigning any reasons.

9. The rate quoted includes all supply, men, material, labour, transportation, and loading and unloading of water at the designated place; nothing is payable extra over and above the quoted rate.
10. The bidder must have a well/ water source within a radius of 10 km in and around the IITDM, Kancheepuram (Melakkottaiyur, Chennai – 127) for ease of delivery and communication.
11. **Quantity mentioned in this tender document may vary as per the Institute's requirement.**
12. The contractor shall ensure that the goods/men/material/vehicle shall be a carriage paid and insured, if needed and possess the necessary certificate as required for the water supply through the tanker.
13. In case of any accidents/incidents/legal issues arising on account of this work shall be the responsibility of the supplier and the Institute shall be indemnified from any claim.
14. The contractor shall ensure that the water supplied shall be of good quality, comply with the Drinking water standards and shall meet the following requirements:
 - 14.1 Shall be free from Odour
 - 14.2 Colour visibility shall be less than 5 Hazen units
 - 14.3 pH value shall lie between 6.5 to 8.5
 - 14.4 Total Hardness shall be less than water shall be less than 200 mg/l
15. The above parameters will be tested by the Institute periodically as and when required. If any tanker water does not meet the above requirement, the Institute has the liberty to return the said load, and the supplier shall arrange the replacement without any additional cost.
16. Penalty for delayed Services / LD
 - 16.1 As time is the essence of the contract, the supplier shall adhere strictly to the Institute's delivery requirements.
 - 16.2 If the supplier fails to supply the water as required, a suitable penalty will be imposed on the supplier.
 - 16.3 The Institute reserves the right to increase/decrease/cancel the quantity of water requirement in case of delay and other quality issues. All disputes are subject to the jurisdiction of courts in Chennai.
17. The bidders have to accept all the terms & conditions of this tender document and it is made known that the bidders quoting for this tender had impliedly accepted the terms and conditions of this tender.
18. If the due date of submission of tender / Tender opening is declared a holiday for the Institute, the due date for submission of tender / Tender opening will be extended to the same time on the next working day.
19. The Institute reserves the right to accept the offer in full or in parts or reject the offer summarily or partly without assigning any reasons.
